## **Topic descriptions**

### Topic #01

#### **Regenerative enterprises and regenerative business models**

A major cause for pressing sustainability challenges is our linear economy in which we deplete natural resources, damage ecosystems and create harm to the ecological environment. In contrast, regenerative forms of business seek to heal ecological damages and regenerate the ecosystems in which they operate. Examples can include climate positive business models or forms of agriculture that increase soil quality, carbon sequestration, and biodiversity.

Thesis candidates are invited to look at these exciting new business models and develop interesting research questions in this field. Candidates will be guided in their formulation of the final research question.

### Topic #02

#### **Forsight Study on Technologies & Sustainability 2035**

The topic covers the research field of sustainability management at the interface with innovation management, in particular the integration of smart technologies. The aim of the thesis is to qualitatively investigate potentials and drivers, but also barriers and concrete application scenarios of smart technologies for sustainability, e.g. in the transition towards a circular economy. Major trends and applications can be deduced from the literature. In addition, experts will be researched and interviewed on possible future topics of the interface. One possibility to approach these expert survey is the Delphi method (within a master thesis).

A possible, preliminary question is: What potentials and application scenarios of smart technologies for sustainability can be expected by 2035?

### Topic #03

#### **Business and Human Rights**

This general topic includes but is not limited to various sub-topics. Students can also propose their own topic within this field:

- management and reporting of corporate human rights performance
- the business case for human Rights
- internal organization, processes and tools for managing corporate human rights performance
- industry and international/cultural differences in corporate human rights strategy
- The role of partnerships for managing corporate human rights performance

### Topic #04

#### **Social Entrepreneurship**

Social entrepreneurship is a novel entrepreneurial form that aims at solving societal problems with commercial approaches and it is increasingly playing prominent roles in many fields, such as education diffusion, environment protection, poverty elimination, etc. Under this topic, possible questions include but are not limited to

- Fostering social entrepreneurship in university students
- Investigating differences among social enterprises and other conventional non-profit organizations
- how social entrepreneurship upgrades itself under the impact of digitalization
- how social entrepreneurship develops in different ecosystems.

### **Bereiche des Nachhaltigkeitsmanagements**

Ziel: Typologisierung der aktuellen Forschung zum Thema Nachhaltigkeitsmanagement

Methode: Überwiegend literaturbasiert + Auswertung der Literatur in diesem Bereich

Kurze Beschreibung: Die Forschung im Bereich des unternehmerischen Nachhaltigkeitsmanagements hat in den letzten Jahren stark zugenommen. Diese Bachelorarbeit soll eine Übersicht der Teilbereiche (z.B. Lieferkettenmanagement, Strategie) erstellen, mit deren Hilfe Schwerpunkte, aber auch weiße Flecken auf der Forschungskarte identifiziert werden können.

Besondere Voraussetzungen: Spaß an der Auseinandersetzung mit der Theorie und Forschungsrecherche; Kreativität; idealerweise Basiskenntnisse in Netzwerkanalyse; Englischkenntnisse

Topic #06

### **Platform based business models in social enterprises**

Social enterprises use their business to address social problems and help their beneficiaries. For example, social enterprises provide better access to health services, education, sanitation, or nutrition to marginalized groups. This topic looks at the role of platform (web-based) solutions and business models that allows social enterprises to increase their impact.

Thesis candidates are invited to look at this area of overlap between digitalization and social enterprises to develop interesting research questions in this field. Candidates will be guided in their formulation of the final research question.

Topic #07

### **Sustainability as a Design Approach**

Sustainability is a question of design. In the sense of the concept of "constraint-based innovation", sustainability can even lead to more creative, innovative solutions. The thesis analyzes sustainability as a design principle in different disciplines, e.g. chemistry, architecture, etc. and derives general design principles. The goal is to create an interdisciplinary, universal design approach for sustainability.

This is a literature-based thesis, which requires solid English and analysis skills.

### **Blockchain and Sustainability (BA)**

Blockchain technologies are discussed as a potentially powerful tool to achieve positive sustainability impacts (e.g. <https://positiveblockchain.io>). Theses in this field can investigate topics that include but are not limited to:

- Cryptocurrencies, blockchains and social enterprises
- Analysis of existing 'positive blockchain' projects and their positive social and/ or environmental impact
- How can blockchain technology enable businesses to address current sustainability challenges?
